In order to continue our progress to achieving net zero, we have adopted the following carbon reduction targets:

We project that carbon emissions will decrease over the next three years to 884 tCO2e by 2028. This is a reduction of 10%.

Completed carbon reduction initiatives

The following environmental management measures and projects have been completed or implemented since the 2019-20 baseline. The carbon emission reduction achieved by these schemes equate to 512 tCO2e, a 34.2% reduction against the 2019-20 baseline and the measures will be in effect when performing the contract.

- Replacement of HVAC system in Reading HQ: FY2024-25
- Rationalising property portfolio to meet logistical needs and reduce energy consumption: FY2020-21, 2024-25.
- Car fleet swap out for more less impactful vehicles: FY2024-25
- Behavioural initiatives to limit energy consumption: Various

- Review and improve procurement activities / processes to ensure ESG and in particular, carbon reporting is central to our supplier selection.
